#### **CEJP STAFF DISCUSS OPERATIONAL PLANNING OF YEAR 2022**

# CEJP RWANDA TOGETHER WITH SCIAF CELEBRATED INTERNATIONAL WOMEN'S DAY 2022 WITH ITS BENEFICIARIES



ON 8TH OF MARCH IN THE OCCASION OF WOMEN'S DAY, CEJP RWANDA **COLLABORATION** IN WITH EAR & WITH THE FINANCIAL SUPPORT OF SCIAF ORGANIZED A TRAINING ATBUTAMWA SCHOOL IN THE CONTEXT OF EMPOWERING YOUNG WOMEN.

This training aimed at enhancing financial literacy in young women in order to fight against economic dependence which is one cause of teenage early pregnancies. Such vocational training is one of the approaches using of CEJP to tackle "economic dependence and sexual ignorance among young people in Rwanda". The current project funded by the Scottish Catholic International Aid Fund (SCIAF) aim to contribute to the alleviation of the problems identified, i.e. economic dependence and the lack of information, training and appropriate orientation in matters of sexuality.

The training has coincided with the celebration of 2022 International women's day where the attendees have been also told about the link between gender, social equity and climate change, and recognize that without gender equality today, a sustainable future, an equal future, remains out of reach. Sister Epiphanie (the one in charge of project management) of the CEJP Side noted: "At the same time, you are effective and powerful leaders and change- makers for climate adaptation and mitigation. You are obliged to be involved in sustainability initiatives around the world, and your participation and leadership results in more effective climate action, that's why you have to work hard for your future."

Looking back on previous lessons learnt from the first phase of the project (2020-2021), Father Charles KARORERO stressed that this workshop will help us to have a better design of the new purpose based on gained experiences and field challenges failures from the first implementation of project range.

#### CDJP BUTARE HAS EMBARKED ON THE CREATION OF **JUSTICE AND PEACE CLUBS IN SECONDARY SCHOOLS AND ENCOURAGING PEACEFUL COHABITATION**

THE DIOCESAN JUSTICE AND PEACE COMMISSION OF BUTARE INITIATED THE PROJECT ENTITLED: "EDUCATION IN HUMAN VALUES THROUGH JUSTICE AND PEACE CLUBS IN THE SECONDARY SCHOOLS OF THE DIOCESE". THE PROJECT STARTED IN 2019 WHERE IT HAS JUST REACHED TEN SCHOOLS. IN JANUARY, THE SAID PROJECT CONTINUED IN THE "INDATWA N'INKESHA SCHOOL (OFFICIAL SCHOOL GROUP OF BUTARE)", WHERE THE JUSTICE AND PEACE CLUB WAS CREATED, MADE UP OF 26 STUDENTS AND 2 EDUCATORS FROM THIS CLUB. IN THIS SAME SCHOOL, TRAINING WAS PROVIDED WHICH FOCUSED ON: CONFERENCES, DEBATES ON PROBLEMS THAT HINDER PEACE IN THE COMMUNITY AND THE ROLE OF YOUTH IN THE PROCESS OF PEACEBUILDING.



The creation of Peace and Justice in Schools should be seen as useful tools promoting Peacebuilding mindset among students. The students from "Indatwa n'Inkesha School (GSO – Butare)" have been trained from January to February 2022 on different methods of entertainment of Peace and Justice club at school. Those methods include short and creative activities going through: Arts, poetry, theatre, music, comic strips, displays, conference-debates, games, community work and so on. By putting in practice what they have learnt the 26 students and 2 educators, they have initiated a banana plantation project where they banana shoots associated with maracuias "ibinyomoro" as part of community work aims to lately support unity and reconciliation activities.

More than 400 people, men, women and young people took part in these debates.

The main key points during the debates were linked to the message of Pope Francis on the occasion of the World Day of Peace where all debate attendees have acknowledged the importance of dialogues between adults and children in Rwandan Culture aims to prevent future misconduct and misbehavior of children and lately adult to be.

#### THE MUPAKA SHAMBA LETU PROJECT ACTIVELY **BUSY-SCHEDULED IN THE MONTH OF MARCH**



Remaining in the busy-scheduled march action of MUPAKA SHAMBA PROJECT, we could also mention the organization of a cross border youth forum on March 9, 2022 at the Rubavu site. The main achieved result of the meeting bringing together 30 young people including 28 women and 2 men was to strengthen the small trade business skills of the targeted group in order to empower and motivate them to drop their fearing to fail aside and remain bold for initiative.

From March 10 to 11, 2022 on the Rubavu site, the CEJP organized a training course for women small cross-border traders who are members of VSLAs (Cross-border Trade cooperative) in entrepreneurship business skills using the CEFE model (Conference based Economy formation). A total of 87% of women took part in this training which was co-facilitated by MUPAKA SHAMBA LETU Project Officers. Key purpose of the training session was to identify major problems hinder women to emerge in their business trade initiatives and also to draft practicable possible solutions which could be use as guide for those women in order to enable them drawing up a flourishing and sustainable business for peace plan(B4P).





### MARCH 2022 ACTIONS ON SOCIAL RECONCILIATION AND REINTEGRATION OF EX- PRISONERS OF 1994 GENOCIDE PERPETRATED AGAINST TUTSIS: CDJP BUTARE AND CDJP KIBUNGO

#### **Happened in Butare:**

On Sunday, March, 20, 2022, In collaboration with the Justice and Peace Commission of the Catholic Diocese of Butare and Magi Parish have concluded the second phase of mental healing, unity and Reconciliation of 247 pilgrims, including 192 former-genocide convicted detainees, who have been released from prison. Among participants, there was a presence of His Excellency Bishop Philip RUKAMBA of the Catholic Diocese of Butare together with the Social Welfare Officer in Gisagara District, and the Executive Secretary of Mukindo Sector, and Representative of the International Alert as well.



#### Followed in Kibungo:

"Getting out of prison didn't really mean my release, said Kaberuka Venant, An Ex-Prisoner and Trainee on Reconciliation"

Kaberuka Venant is one of participants in training on healing and reconciliation organized by Justice and Peace commission in Kibungo Diocese, who said course on begging pardon was a bridge to release his heart. Six months ago after training on healing and reconciliation funded by Trocaire Rwanda which brought together Genocide survivors and Genocide convicted in course of healing and reconciliation, Kibungo Peace and Justice Commission is getting more testimony on the fruit of training done last year of 2021.

Kaberuka Venant was born in 1962, married and father of 5 children, lives in Kirehe district, Kirehe sector, Nyabikokora Cell in Kwihanika Village. He admits to have played a big role in the Genocide against Tutsi in 1994. He said: "I cannot say everything about all that happened in the Genocide against Tutsi, but I want to talk about some important event according to this Genocide and after my release in prison. I especially want to talk about the role of the Justice and Peace Commission of the Catholic Diocese of Kibungo (CDJP Kibungo) in terms of Unity and reconciliation of genocide convicted and Genocide survivors healing of hearts. Returning from Tanzania in 1998 where we had taken refuge after committing Genocide, I was imprisoned for the role that I played in the Genocide against the Tutsi in 1994."

continued: Kaberuka However the as Rwandan government called us accept the crime that we had committed, ask for forgiveness and tell the truth of what we did during Genocide, I was among the first to accept my crime and ask for forgiveness. This was done to reduce my sentence, which is why I am now at large. But as, getting out of prison didn't really mean my release. It was only a physical liberation but my heart still remained guilty because the forgiveness I had asked for was only superficial as it did not touch the one or those against whom committed the Genocide.

testimony therefore consists thanking the Peace and Justice commission for my true and total liberation. Indeed, after my release from prison, I did not know the reality on the outside so how to find myself with the ones or those against whom I have offended. I didn't know how I should live with them. Either way, I knew they would get revenge because what I had done to them was unforgivable to me.



I had never been quiet, my heart was always upset always wanting to escape and avoid all the opportunities that could make me cross with them, especially with Kigonda Venant with whom we live in the same village and against whom family during this exterminated the genocide. Since leaving the training, I have found the courage and strength to return to mass to pray. The gospel of the prodigal son that the parish priest read to me comforted me and brought back to me the hope of being a child of God, when I had completely despaired.

It was already 27 years without thinking of treading the soil of the parish and church. entering the In addition. associating ourselves in a savings and loan groups with the people against who we committed the Genocide will allow us to ask for me forgiveness and possibly obtain forgiveness from them.

To be retained from social actions of social reconciliations and social reintegration in both CDJP Butare and **CDJP Kibungo:** 

Activities aimed at clapping the gesture towards the acceptance of crimes and a willingness to ask for forgiveness on the former-genocide convicted detainees, and appreciate the initiative of forgiveness recognition at the side of Victims of Genocide perpetrated against Tutsis, which is among the the emblems of reconciliation social social and reintegration processes.

## COMMISSION IN CHARGE OF SOCIAL AFFAIRS AND HUMAN RIGHTS OF THE PARLIAMENT OF RWANDA VISITS CDJP BYUMBA

On February 9, 2022, In their field assessment visits, on the results carried out by the unity and reconciliation groups that have been created throughout the country, Senators Faustin HABINEZA and Cyprien NIYOMUGABO, members of the commission in charge of social affairs and human rights of the Parliament of Rwanda visited the group "Ntibizongerukundi" bringing together formergenocide convicted detainees and victims of Genocide perpetrated against in Muko sector, Gicumbi District and appreciated the achievements of the group in the unity and reconciliation of members as well as their socioeconomic development thanks to the "Project for the psychosocial and economic rehabilitation of prisoners for their reintegration into family and community life HINDUKA UGARUKE TWIYUBAKE.

The visit intended to assess the field based Reconciliation and Reintegration activities of HINDUKA UGARUKE TWIYUBAKE project in the aftermath of 1994 Genocide perpetrated against Tutsis. The project focuses on the lessons learned and current situation in terms of reconciliation and reintegration efforts, by fostering Reconciliation and Socio-Economic Reintegration where the group "Ntibizongerukundi" focalize in psychosocial care activities, healing of wounded hearts, improving peaceful cohabitation and promoting of initiatives of reconciliation.



### CDJP CYANGUGU AT THE SERVICE OF RUSIZI AND NYAMAGABE PRISONS

Cyangugu Justice and Peace Commission in psvchosocial and economic its rehabilitation of prisoners for reintegration into family and community continuously supported community and prisoners ready to serve their sentences in order to be properly the community integrated into promote cohesion social. It is in this sense that the Justice and Peace Commission works closely with Rusizi prison for the supervision and support of prisoners.

In collaboration with the NPIA "Noyau de Paix Isoko ry'Amahoro", the Justice and Peace Commission of Cyangugu wanted to extend this support to the Nyamagabe prison housing the women. It is in this sense that, since February 2022, it has established collaborative relations with RCS "Rwanda Correction Service" with Nyamagabe prison so that women detained there can also benefit from this support in the same way as men. The assistance beneficiaries focuses provided to equipment for learning trades and support in counseling aimed at the reconciliation process as part of preparing for their future integration into the community once released.



#### **CPJP Hanika was visited....**



The theme of peace, justice reconciliation become maior has a cooperation for the staff concern project within the Diocesan Justice and Peace Commission (CDJP) of Cyangugu. To meet these challenges, the CDJP collaboration with the in Cyangugu cooperation SCPunder the AGIAMONDO project has set up bodies at the level of the Parish Justice and Peace Commissions (CPJP) to properly iustice implement peace, reconciliation activities in the parishes through volunteers trained in these areas.

At the CPJP Hanika, the work of Justice, Peace and Reconciliation is done by volunteers where the planned activities are piloted by the CPJP committee at the parish, central and CEB levels. They meet once a month where they evaluate all that has been done and see together the activities that will be carried out in the future.
